Sealed Bids for the construction of the Drummond Dam Repairs 2022 project will be received by Bayfield County at Bayfield County Courthouse, County Administrator, 117 E 6th Street, P.O. Box 878, Washburn, WI 54891 until 11:00 a.m. local time on March 28, 2024, and electronically through www.QuestCDN.com. At which time the paper and electronic bids received will be publicly opened and read aloud. The Project consists of concrete rehabilitation and minor repair of various dam components.

Bids will be received for a single prime Contract. Bids shall be on a lump sum basis.

Upon request and receipt of the document payment indicated above, the Issuing Office will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

The bid proposal shall be accompanied by a certified check or bid bond in an amount not less than 5% of the maximum bid price, payable to Bayfield County, as a guarantee that the bidder, if bid is accepted, will execute and file the proper contract and 100 percent performance and payment bonds within 15 days after the Notice of Award. In case the Bidder fails to file such contract and required bonds, the check or bid bond shall be forfeited to Bayfield County as liquidated damages.

Letting of contracts will be subject to Section 66.0901 Wisconsin Statutes, Public Works, Contracts, and Bids. Bayfield County reserves the right to waive any formalities in the preparation of a bid and to reject any or all bids. No bidder may withdraw his bid within 60 days after the scheduled time of bid opening.
